 - This includes Year-End Statement for IRA/Annuity accounts. Year-End Statements are provided by the IRA company/bank. **Income tax preparers do not use this Annual Statement/Year-End report.**
 - IRA *distribution* is NOT included in income.

- 1. READ ALL THE INFORMATION ENCLOSED**
- 2. MAKE COPIES OF YOUR 2020 FEDERAL/STATE INCOME TAX RETURN or MAKE COPIES OF ALL YOUR INCOME STATEMENTS (1099'S) FROM 2020 (USE THE CHECKLIST ENCLOSED)**
- 3. FILL OUT THE RENEWAL APPLICATION AND SIGN IT ***INCLUDE PHONE NUMBER & EMAIL ADDRESS*****
- 4. SAFE STEPS IF YOU DON'T WANT TO RENEW YOUR DISABILITY EXEMPTION IN PERSON**

2 OPTIONS FOR TOUCHLESS RENEWAL

- **BY MAIL** – ***PLACE ALL YOUR INFORMATION AND APPLICATION IN AN ENVELOPE ALONG WITH A SELF ADDRESSED STAMPED ENVELOPE (WE WILL MAIL YOU BACK A COPY OF YOUR APPLICATION AS YOUR RECEIPT. PLEASE INDICATE IF YOU WANT YOUR STATEMENTS SENT TOO)***
