- 2 Once you have paid, you will get an automated email prompting you to schedule an inspection on an online form with your assigned inspector. You must be sure to schedule an inspection with the inspector you are assigned.
- For long term rental unit registrations, if you pass your inspection, you will be granted your certificate and will have to renew in 3 years or upon a transfer in ownership of the dwelling. For short term owner occupied (30 days max), you will need to pay an annual fee (see front for pricing).
