Project Description

This project will make improvements to pedestrian facilities at thirty-two locations throughout Erie County, two signalized intersections and thirty uncontrolled crosswalks. This effort is part of the New York State Pedestrian Safety Action Plan (PSAP) announced by Governor Cuomo on June 20, 2016.

Project Objective

The purpose of this project is to implement engineering countermeasures that improve pedestrian and roadway safety as described in the NYS Pedestrian Safety Action Plan. This approach will proactively address safety issues and minimize crash potential by implementing countermeasures at various locations within the County. All work will be performed meeting current standards and PSAP guidance.

Project Locations

Project Locations are in the Village of Alden, Town of Clarence, Town and Village of Hamburg, Town of Lancaster and Village of Williamsville. Exact locations are listed on the back of this page.

Proposed Improvements

All work will be performed following PSAP guidance and current design standards.

Signalized Intersections:

- o Back plates with retroreflective borders
- New pedestrian signals with APS (Accessible Pedestrian Signal)
- New crosswalk striping
- Replace sidewalk curb ramps not meeting current standards

Uncontrolled Crosswalks:

- Advance warning signs, Back-to-Back signage at the crosswalk, reflective sign post strips and new crosswalk striping
- Rectangular Rapid Flashing Beacons (RRFBs) to be considered at select locations

Impact to Traffic

Work zone traffic control will consist of temporary lane closures and sidewalk detours. Street traffic will be restored to the existing configuration at the end of each work day. Sidewalk closures will continue overnight while newly placed concrete cures.
